### ORDER:

In the G.O. 1<sup>st</sup> read above, the Government have incorporated the Andhra Pradesh State Christian (Minorities) Finance Corporation, to cater the need of the social betterment, Economic Development of the Christian Minorities of the State.

2. In the reference 2<sup>nd</sup> read above, the Board of Directors, Andhra Pradesh State Christian (Minorities) Finance Corporation in its Board Meeting held on 12.05.2014 have resolved for the Demerger plan of the existing Andhra Pradesh State Christian (Minorities) Finance Corporation. The Demerger plan is under the examination of the Expert Committee created vide reference 5<sup>th</sup> read above.

3. In the reference 7<sup>th</sup> read above, the Managing Director, A.P. State Christian (Minorities) Finance Corporation, has requested the Government to accord permission to register new Company under Section 25 of the Companies Act, 2013 as non profit motive organization and also carry out the activities connected with formation of new Corporation (Company) on account of bifurcation of the State.

4. Government after careful consideration of the matter hereby decided that the existing Andhra Pradesh State Christian (Minorities) Finance Corporation needs to be demerged into Telangana State Christian (Minorities) Finance Corporation and Andhra Pradesh State Christian (Minorities) Finance Corporation, accordingly, the Assets and Liabilities are to be apportioned in accordance with the A.P. Reorganization Act, 2014. The same will be done after the receipt of the report of the Expert Committee. In the meanwhile the corresponding mirror entity i.e., Telangana State Christian (Minorities) Finance Corporation needs to be created in order to receive the Assets & Liabilities from the Andhra Pradesh State Christian Minorities Finance Corporation, on Demerger.

5. Accordingly, Government hereby accord permission to create the Telangana State Christian (Minorities) Finance Corporation under Companies Act, 2013 with its registered office at West side of H.No. 6-4-941, Flat No. 102, Moghal Emami Mansion, Khairtabad, Hyderabad.

6. The task of forming and registration of the Telangana State Christian (Minorities) Finance Corporation, is hereby entrusted to the Managing Director, Andhra Pradesh State Christian (Minorities) Finance Corporation.

7. The Memorandum of Association (MOA) and Articles of Association (AOA) of Telangana State Christian (Minorities) Finance Corporation, are herewith approved and appended to this order.

8. The following shall be the Board of Directors to the Telangana State Christian (Minorities) Finance Corporation:

- i) Secretary to Govt., Minorities Welfare Department, Telangana who will be the Ex-Officio Chairperson.
- ii) Secretary to Govt, Finance Department, Telangana.
- iii) Director, Minorities Welfare, Telangana who will be the Ex-Officio Managing Director.

9. The authorised share capital of the Corporation shall be Rs.10,00,000/- (Rupees Ten Lakhs Only) with initial paid up capital of Rs.5,00,000/- (Rupees Five Lakhs Only)

10. The following shall be the authorised share holders to the Memorandum of Association of the Corporation:-

The Andhra Pradesh State Christian (Minorities) Finance Corporation is hereby accorded permission to release an initial amount of Rs.5,00,000/- (Rupees Five Lakhs Only) towards the Government's share capital contribution to the new Corporation as advance and later these amounts shall be debited to the new Corporation account from the amounts to be distributed between the Corporations.

12. The Andhra Pradesh State Christian (Minorities) Finance Corporation is hereby accorded sanction to release an amount of Rs.1,00,000/- (Rupees one lakh only) to incur expenditure towards the registration of new Corporation under the Companies Act, 2013 for filing fees, registration fee, stamp duty, printing charges, professional fee for engaging Company Secretary etc. Later these amounts shall be debited to the new Corporation account from the amounts to be distributed between both the Corporations.

13. The Director, Minorities Welfare and the Managing Director, A.P. State Christian (Minorities) Finance Corporation, Hyderabad shall take further necessary action accordingly in the matter.
