1. *The proposals for financial assistance should be submitted by the Burial Ground Committees / village Panchayat / Municipality to the Managing Director, TSCMFC or to the E.O.District Manager concerned in the Districts.*
2. *It is mandatory for the applicant to fill all the columns. Incomplete application forms will be summarily rejected without any notice.*
3. *Application should be enclosed with all required documents. All documents to be attested by Head of the institution.*
4. *The DWMO would personally inspect the proposals received in full shape along with all mandatory documents and if satisfied would circulate the file to the District Collector and send three copies of the proposal to the Managing Director, TSCMFC only after obtaining District Collector's approval.*
5. *All the instructions issued by the Government of Telangana State should be scrupulously followed by the applicant and DMWO while forwarding the proposal.*
6. *The financial assistance shall not exceed Rs.3.00Lakhs per acre in rural areas and Rs.5.00Lakhs per acre in urban areas or as per actual estimates, whichever is less.*
