ORDER:

In the proceedings read above, the Special Secretary to Government, Minorities Welfare Department has passed note orders to release amount to the District Collectors for the 17 beneficiary institutions for which administrative sanction has been issued by Government since they have submitted all mandatory documents and also gave permission to MD to release budget to the District Collectors for the works for which administrative sanction has been issued by the Government as and when all mandatory documents are received.

ORDER:

In the proceedings read above, the Government has issued admin sanction for 671 Civil works in Churches & Church run institutions and as on date vide ref (5) cited, this office has released amount to the District Collectors for 25 beneficiary institutions which have submitted all mandatory documents and as on date still 646 beneficiary institutions have not submitted all mandatory documents.

In the ref(1) cited, orders have been passed by the Special Secretary to Government, MW to release the amount to the District Collectors for the 646 beneficiary institutions which have not submitted all mandatory documents. Since the state bifurcation date is fast approaching and if the amount is not released to the districts, the accounts of APSCMFC cannot be finalized.
