Therefore, it is requested to issue directions to all the Tahsildars to issue ST and BC-C Certificate to the applicants in accordance with the G.O.s and the clarification issued there-in, duly following the procedure scrupulously.

Attention of all the District Collectors in the State is invited to the  
reference cited, wherein the Director, TCR&TI of Tribal Welfare  
Department has issued the following clarification on capturing of religion  
status for Scheduled Tribes to issue the Community and DOB and Nativity  
Certificates.

1. The Tribal Communities have their own belief system and do not  
practice any established religion.
2. As per Form-1 under section 3(1) and 3(2) and 16 of 1993, the  
religion does not find any importance for issuance of Community,  
Nativity and Date of Birth Certificate relating to Scheduled Tribes.

In view of the above, the District Collectors are requested to  
communicate the above clarification to the concerned competent  
authorities (i.e., Tahsildar/RDO/Assistant Collector) for Information and  
necessary action while issuing the Community and Date of Birth  
Certificate and Nativity Certificate to Schedule Tribe communities.
