ORDER:

In the reference 2nd read above, the Hon'ble Minister for Energy, Scheduled Caste has submitted a proposal for sanction of Grant-in-aid for Construction of Church Salem House of Prayer at Nalgonda town & District.

Government after careful examination of the matter, hereby accord Administrative Sanction for an amount of **Rs.36,00,000/-** (Rupees Thirty Six Lakh only) towards sanction of Grant-in-aid for Construction of Church Salem House of Prayer at Nalgonda town & District **in relaxation of the existing rules, treating as a Special Case.**

The Director, Minorities Welfare/the Managing Director, Telangana State Christian (Minorities) Finance Corporation, Hyderabad is hereby requested to release the amount sanctioned at Para-(1) above, to the District Collector, Nalgonda, **subject to obtaining the required proposals from the District Collector, Nalgonda as per the exiting guidelines issued vide G.O. 1st read above, before releasing the funds.**

4. The amount sanctioned in Para (1) above, shall be debited to the Head of Account "**2225 - 80 - 190 - 25 - 06 - 310 - 312**".

5. The District Collector, Nalgonda is requested to comply with the orders issued in the G.O. 1st read above, and incur the amounts for which the sanction are accorded and send Utilization Certificates to the Government.
